2 OPEN GOVERNMENT PARTNERSHIP



Is not...

- A distraction or a luxury
- Meetings to “take the picture”
- Publish some easy data
- E-gov and electronic platforms
- Just access to information, transparency or open data

It is...

- Collaborate to tackle tough problems
- Foster human rights
- Co-create good public policies
- Built on what is good and improve
- Create stronger coalitions to solve problems
- Fight corruption and improve public services

Open Government Partnership



- + International multi-stakeholder platform to make governments more accountable, inclusive and responsive to citizens



- + Founded in 2011 by eight governments and nine civil society leaders



- + Now involves 78 national and 20 local governments, and thousands of civil society organizations - who have together developed over 4,095 commitments



- + Governed by a Steering Committee composed of 11 governments and 11 civil society leaders

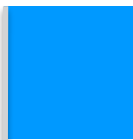


A unique model



Civil society and government define the agenda

- + Government and civil society organizations share the table and work in team, as allies.



Action plans with specific commitments

- + Acknowledges that countries and governments have different starting points.



Accountability

- + Independent Reporting Mechanism
- + Self assessment reports and online repository

Policy Areas

- + **28 members** advancing on **Beneficial Ownership** reforms
- + **42 members** advancing on **Civic Space** reforms
- + **51 members** advancing on **Extractives** reforms
- + **41 members** advancing on **Gender** reforms

- + **15 members** advancing on **Lobbying** reforms
- + **89 members** advancing on **Fiscal Transparency** reforms
- + **69 members** advancing on **right to information** reforms
- + **62 members** advancing on **Justice** reforms
- + **37 members** advancing on **Open Contracting** reforms

Focus theme: Anti-corruption




- + **Open Data Program to Combat Corruption - PIDA**

- + Costa Rica and Colombia (recent commitment).



- + **Open Contracting**
Argentina, Chile, Ecuador, Panama, Paraguay, Peru, and Uruguay.



- + **Beneficial Ownership**
Community of practice that includes Chile, Costa Rica, Mexico, and Paraguay. Interest in Panama.



- + **Social audit on covid emergency**
Colombia drafted a commitment on social audit on covid emergency projects.

Ukraine

- + Prozorro, an online platform to disclose all procurement contracts and make it publicly searchable





United Kingdom

- + Implementing public register for beneficial owners of British companies to disclose who ultimately owns, controls, and benefits from them

Kaduna, Nigeria

- + “Eyes and Ears” project enlists citizens to monitor government infrastructure



Georgia

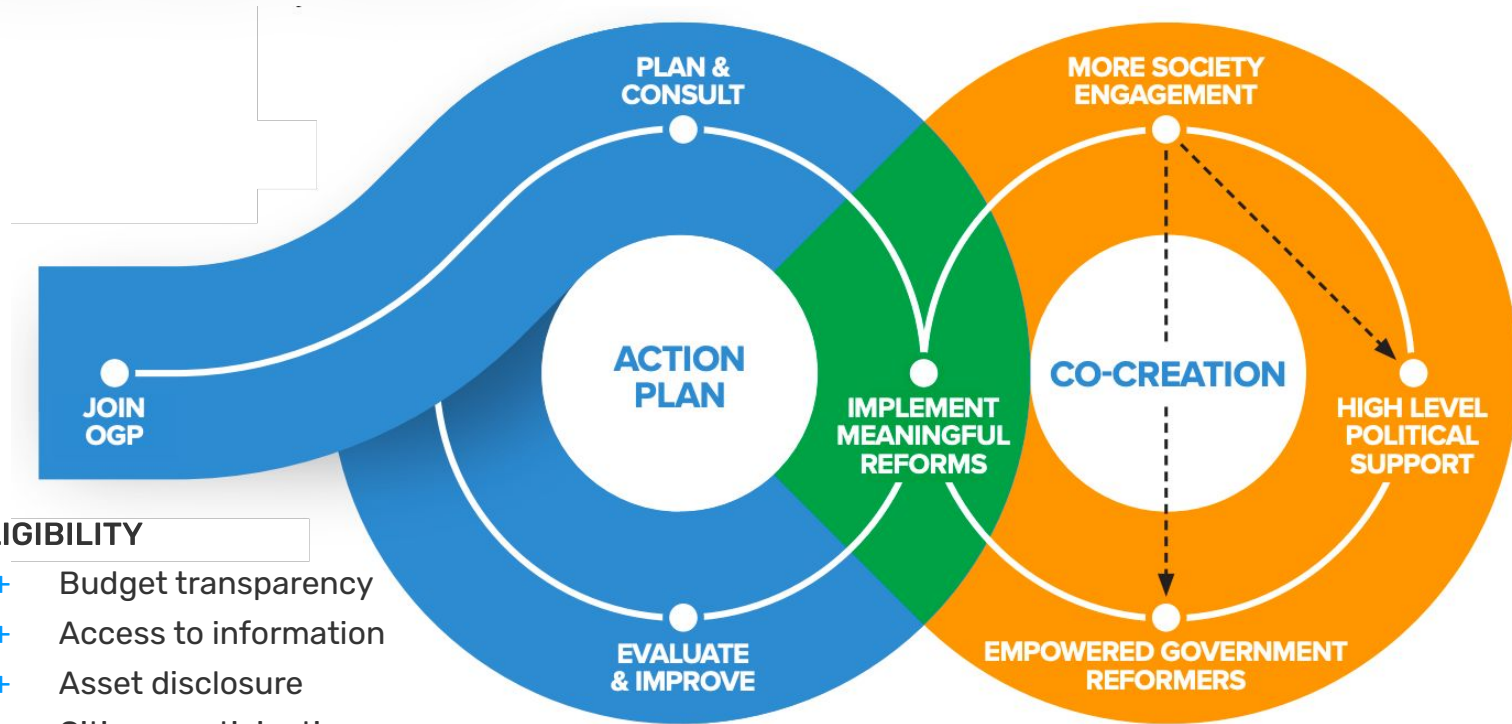
- + Publishing searchable political party financing data to track whether donors and political parties are illicitly benefiting from government contracts



Chile

- + **Creation of Fiscalía Nacional (independent prosecutors office), access to information act, anti-money laundering reform, and multiple efforts to regulate peddling in Chilean politics**

How OGP works



+

ELIGIBILITY

- + Budget transparency
- + Access to information
- + Asset disclosure
- + Citizen participation



What is the IRM?

+ OGP's accountability arm

- Independent body, overseen by the International Experts Panel (IEP)
- Assesses the design of OGP action plans to determine:
 - How well the commitments reflect the OGP values of transparency, accountability, and civic participation
 - How ambitious they are in opening up government and changing business as usual
- Monitors the implementation of OGP commitments throughout the two-year action plan cycle



Guiding materials

- **OGP Handbook 4.1: Rules and Guidance for participants (Updated January 2020).** In this document you will find information about the OGP calendar, rules about delays, advice on how to handle electoral/transitional processes, and guidance on how to develop an Action Plan and Self-Assessment Report.
- **OGP Participation and Co-creation Toolkit.** The Participation and Co-creation Toolkit provides guidance on developing successful co-creation and implementation processes in line with the requirements established in the OGP Participation and Co-Creation Standards.
- **OGP Global Report.** The Global report is a comprehensive assessment of the state of open government. This report provides a thorough and honest review of progress made by OGP member countries in the first eight years of the partnership.

Co-creation standards

Information divulgation and comms

Basic

- + OGP online dedicated space with repository
- + Timely publication of activities (calendar, opportunities of participation, general information, etc.)

Advanced

- + Online participation and deliberation mechanism (comments, etc.)
- + Public follow up mechanism and periodic implementation updates

Co-creation standards

Spaces and platforms of dialogue and co-creation

Basic

- + Opportunities for everybody to participate in the process
- + Multi-Stakeholder Forum
- + MSF methodology (four meetings each year)

Advanced

- + Thematic working groups
- + Regular meetings, dialogue and consultation with the responsible public servants/agencies of the commitments.



Co-creation standards

Ownership and joint decision making

Basic

- + Joint development of rules and governance of the MSF
- + Balance between Gov and CSO integration and participation (CSO representatives with decision making power)
- + Fair and transparent selection process of the civil society representatives
- + MSF communicates decisions, activities and results

Advanced COMMITMENT PARTNERSHIP

- + Co-direction of the MSF and empowerment for decision making
- + Joint monitoring of commitment implementation



- + IRM will evaluate that the Government at least, **involves** during co-creation and **informs** during implementation.

Co-creation

Involve:

- + There is an MSF
- + MSF publishes decisions and gives reasoned responses

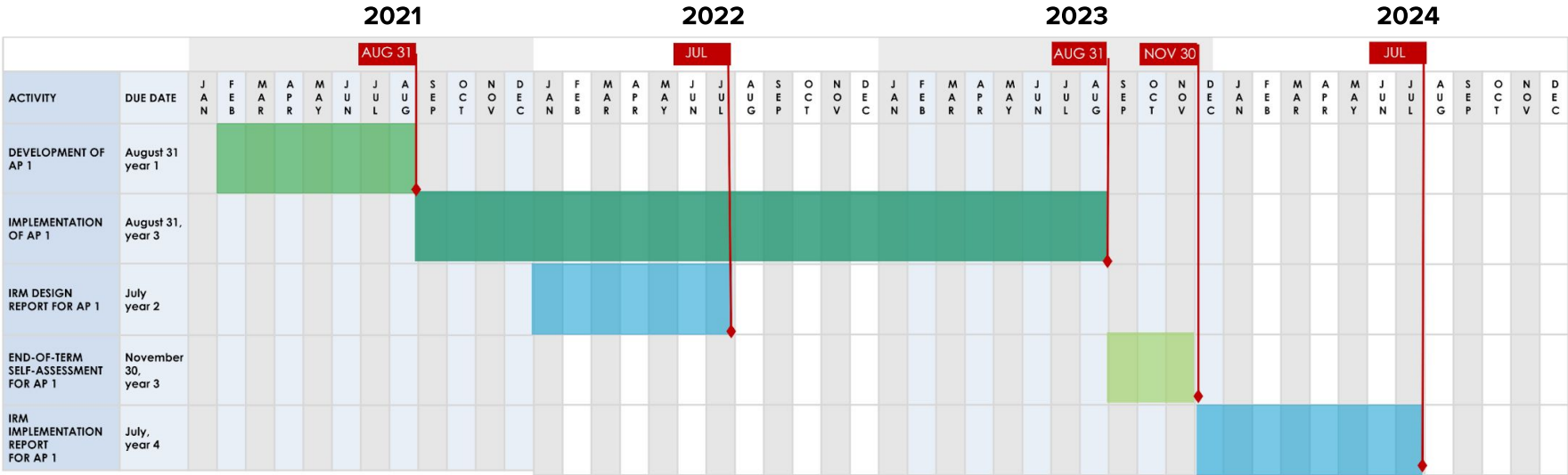
Implementation

Inform:

- + Information to follow up commitments
